<b>What is the overall deductible?</b>	In- <u>Network</u> : \$500 Individual / \$1,000 Family Out-of- <u>Network</u> : \$5,000 Individual / \$10,000 Family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
<b>Are there services covered before you meet your deductible?</b>	Yes.	You will have to meet the <u>deductible</u> before the <u>plan</u> pays for any services.
<b>Are there other deductibles for specific services?</b>	Yes. \$1,000 <u>deductible</u> for In- <u>Network</u> hospital admission. There are no other specific <u>deductibles</u> .
