#### Financials:

Bismarck-Henning CUSD #1 moved and GCMS Community Unit School District #5 seconded the motion to approve financials through June 24<sup>th</sup>. The financials show income as \$1,631,334.54 and expenses totaling \$1,475,166.10 for an actual net monthly income of - \$156,168.44. Balance in the trust account is \$1,546,026.35. Unpaid claims total \$0, total claims for the month are \$1,322,078.48. Georgetown-Ridge Farm paid the rest of the IBNR payments for the rest of the year – which totaled \$35,503.88.

### Discussion and vote on hearing aid benefits:

GCMS Community Unit School District #5 moved and Heritage Community Unit School District #8 seconded the motion to approve on the hearing aid benefits starting at renewal, January 2022. This will be on an endorsement/rider under each district's policy and districts will have to decide if they want this benefit or not. Pricing will be based off of Tier 7 rates on the POS 2500 100% and there will be a 2.50% charge for each district who participates.

# Discussion on OSF OnCall Digital Health:

Brian Loman and Kris Elliot presented the OSF OnCall Digital Health virtual visit program. This program is another telemedicine program which is available 24/7/365. Pricing is based on purchasing a block of virtual visits starting from 1,000 visits. HealthiestYou has decided to give us a 12 month flat increase so the Executive Board decided to hold off another year on shopping out the telemedicine program.

**Discussion on Telehealth Coverage based on the Executive Order -Gail Heaton:** Gail Heaton recommends taking off the Executive Order for virtual visits being covered at a \$0 copay for the members and the plan covers 100%. GCMS Community Unit School District #5 moved and St. Joseph-Ogden CHSD #305 seconded the motion not to follow the Executive Order Telehealth visits will still be available but at the cost of the member and not the plan.

### Discussion on adding new plans for 2022:

Brian Loman wants to look onto adding some HDHP Qualified and HDHP HRA plans that will work either with HRA's and HRA's. The Executive board is interested in adding some plans so Kelly Grebinsky will be working on pricing and will give us information during July's meeting.

### **Update on Nurse Navigator and Strive for Five:**

Nurse Kris Elliot will be reaching out to 20 members who she thinks she might be able to help save them money via labs, etc. In this letter she we be introducing herself and informing the members of the benefits of the Nurse Navigator and Strive for Five program.
