Financials:

Bismarck-Henning CUSD #1 made the motion and Fisher CUSD 1 seconded the motion to approve financials through September 23rd. The financials show income as \$1,696,823.22 and expenses totaling \$1,566,907.31 for a net monthly income of \$129,915.91. Balance in the trust account is \$1,476,030.15. Unpaid claims total \$0, total claims for the month are \$1,409,092.72

Speaker Kelly Grebinsky, Actuaries Northwest, to discuss 2022 renewal:

Kelly Grebinsky discussed the 2022 renewal and recommends the trust to take a 8.9% aggregate rate increase. The rate increase is comprised of the following: 2021 rate understatement, 2022 claims trend, changes in stop loss/admin fees and changes in future risk. In 2021 there were higher general claim trends including high-cost claimants and deferred services related to COVID. Annual trends rates are 5.4% for medical can 8% for prescription drugs.

Discussion and vote on ASO renewal:

Paxton-Buckley-Loda Community Unit School District #10 made the motion and St. Joseph-Ogden CHSD #305 seconded the motion to approve the 2022 ASO renewal. For 2022, the ASO fees will go from \$28 PEPM to \$28.80 PEPM.

Discussion and vote on Stop-Loss renewal:

Fisher CUSD 1 made the motion and Bismarck-Henning CUSD #1 seconded the motion to approve the stop-loss renewal. Stop loss renewal came in at a 7.96% increase going from \$42.31 to \$45.69 PEPM and the stop loss amount is staying at \$150,000.

Discussion and vote on 2022 renewal:

Fisher CUSD 1 made the motion and GCMS Community Unit School District #5 seconded the motion to approve the 2022 renewal at an 8.9% aggregate increase for the entire trust.
