### **Vendor Reports:**

BCBS- Ainsley McDaniel – went over the 2024 utilization report. Top diagnostic category – neoplasms/cancer. Over 50% of the top large claimants have a cancer diagnosis. Large claimants account for 4.5% of membership and 49% of paid dollars are attributed to large claimants. On the pharmacy side, the #1 non-specialty medication is Wegovy and #1 non-specialty therapeutic class is Incretin Mimetic Agents (GLP-1). #1 specialty drug class is Autoimmune – Humira & Stelara. Wellness programs members are utilizing: - Teladoc, Hinge Health, Wondr and Twin Health.

**General Agent Report** – Tresica Foreman went over the results of the IERMP/GA survey. Mostly received 4 & 5's. We will be reaching out to those who gave less than a 4 rating to provide input. Surveys should be done annually.
