**General Agent Report – Brian Loman** – The trust has two CD's maturing: \$250,000 in November, \$1M–\$1.25M in December. Money market interest rates are currently 4.05%+, higher than 12-month CD (3.5%–3.65%). Plan to roll November CD into money market and decision pending on laddering or keeping funds in money market for December maturity. Interest rates are currently declining, monitoring for optimal allocation.

\$1,500 was paid to Kelly in error from IERMP account. The invoice was for an RFP Kelly worked out for a district outside the IERMP. Funds have been refunded to the correct account.
